

# CONNECTING TO RE-STREAM C&A

- · Search for new devices from car radio interface or phone.
- Confirm/accept the prompts in phone to use wireless CarPlay / Android Auto.



### UPDATE & CUSTOMIZE

- Disconnect iPhone from C&A by disabling bluetooth on iPhone and restart C&A.
- Connect iPhone to C&A Wifi network with passcode 12345678.
- Scan the QR-code with your device camera or navigate to 192.168.50.2 and follow on- screen instructions.



### SETTINGS EXPLANATION

- Sync mode Normal: Resolve instrument panel display problems. - Compatible: Resolves the issue of certain vehicles not connecting to the dongle. - Background: Used in cars that show black screen after connection.
- Knob mode **CON**: Default for most cars **ALL**: Used when bottom icons in Android Auto cannot be choosen due to radio knob controller.
- Video resolution Change Android Auto resolution.
- Video Bit rate Makes Apple CarPlay pictures more high definition but use more data.
- DPI Change Android Auto icon size
- Startup delay If you set it for 5 seconds, the adapter will start the system after 5 seconds of connecting to USB port.
   Used in cars where system cannot recognize the adapter or the adapter works only when to replugged.
- GPS Turn on this function, the adapter will help iPhone to obtain more accurate positioning.
- Reset Reset all settings of the device.
- Rollback Downgrade to previous version firmware.
